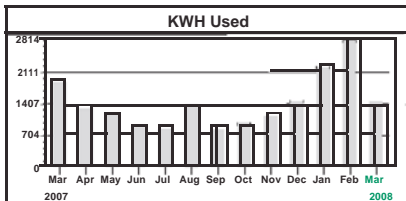

BILL DISPUTES

If you dispute the correctness of this bill, please contact Emerald PUD either by phone or in person. If the dispute is not resolved, supervisors are available to review the bill with you. If a dispute remains, you have the right and will be encouraged to have an informal conference with an employee designated by the Manager of Finance and Administration.

REPORTING POWER OUTAGES

- If electric service is interrupted, check your fuses or circuit breakers before contacting Emerald PUD.
- Check to see if your neighbors are experiencing a power outage.
- Call Emerald PUD at 541-746-1583 or toll-free in Oregon 800-422-4086 if you believe the issue is on Emerald PUD lines or equipment.
- Your Account Number is helpful to identify your location so please have it on hand when you call.
