Luminaries shall be mounted on Emerald-owned wood pole or other approved structure and served in accordance with Emerald's specification as to equipment and installation.

AGRICULTURAL PUMPING SERVICE

4. Customers may "self-read" meters during the irrigation season and will be billed monthly for demand and energy charges rather than on a twice-yearly basis. Emerald PUD will furnish meter-reading cards to customers desiring to read their own meters.
5. A delinquency charge of 1.00% per month will be added to all unpaid bills. Unpaid accounts will not be connected at the beginning of the season, and a deposit may be required equal to the prior year's billings.
